Objective of the assignment	The objective of this assignment is to design an ICT database system that captures all NCCR members information and activities.

A. Background information

The National Cooperatives Confederation of Rwanda (NCCR) is the private umbrella organization that promotes and represents the interests of the cooperative movement in Rwanda. On 28th October 2010, the National Cooperatives Confederation of Rwanda (NCCR) was established by nine cooperative federations. The NCCR was granted legal entity on 22 December 2010 and this was published in the Official Gazette N° 25 of 20/06/2011. In 2012, the NCCR joined the International Cooperative Alliance ([ICA,https://www.ica.coop/en](https://www.ica.coop/en)), which is the body that represents and serves cooperatives worldwide.



Currently, NCCR has increased membership to 14 federations namely: FECOMIRWA (Mining), FECOPPORWA (Irish Potatoes), FEFICOORWA (Fishing), FERWACAPI (Beekeeping), FERWACOTAMO (Motorcycles), FERWACOTHE (Tea), FUCORIRWA (Rice), NDFFR (Livestock), RCCF (Coffee), RFTC (Minibuses + Coasters), RFWC (Wheat), RWCCF (Cassava), FCMR (Maize) and RFHC (Horticulture).

NCCR's **Vision** is "**Life without Poverty**" has been inspired by the global sustainable development agenda (2016 – 2030). Given the inter-relatedness and integrated nature of the SDGs, NCCR wants to contribute to each of them with emphasis on **People, Prosperity and Partnership**.

Mission Statement: We exist to support our member Federations, Unions and Primary Cooperatives through capacity development, information sharing, advocacy and collaboration with Public, Private and Civil society organizations at local, Regional and International levels.

B. Issue Description:

Rwanda as a country is steadily moving forward in the quest to become a knowledge-based economy, every year the country registers achievements in the ICT sector, which remains one of key enablers of such an ambition. Many institutions whether public or private are fast learning to adopt to ICT usage and application. NCCR is one of such institutions that wants to fully embrace ICT in its operations. As mentioned earlier, National Cooperatives Confederation of Rwanda (NCCR) is the umbrella organization that promotes and represents the interests of the cooperative movement in Rwanda. This association has many operations, but many of its operations are not digitized. For example NCCR doesn't have a data base for its members. The confederation is not able to know its actual membership. The confederation has difficulties to plan for membership and apart from knowing the number of federations, NCCR might not know the real number of its members. Developing a database for information management is therefore crucial to improve data management, planning and decision making of NCCR. This is the main reason why NCCR needs assistance on developing and designing a Database system.. The development of NCCR data base, will increase the organizational efficiency.

C. Objectives of the Assignment

The objective of this assignment is to design an ICT database system that captures all NCCR members information and activities.

More specifically,

- Design or develop a database as desired by the host.
- Prepare design specifications and functional documentations for the database
- Train NCCR Staff on the management Data management system that will have been set up.
- Developing protocols for data processing by NCCR and members
- Develop instructions on the usage and management of the data management system.
- Identify any issues related to database performance and provide recommendations / measures
- Test run the database to ensure it works well.
- Organize a half -day presentation to company members, to share the assignment report and recommendations.



D. Host Contribution

To conduct this assignment, NCCR is expected to meet the following requirements:

- Avail NCCR staff and identify key federation members who will be involved in the consultation and database system designing process.
- Avail staff who will be trained on the data management, usage and maintenance .
- Identify a translator to work with the volunteer
- Provide venue for the volunteer assignment and any other logistics
- Commit to implement all the recommendations provided by the volunteer (s) after the completion of the assignment.

E. Anticipated results from the Assignment;

Following the completion of this assignment, the outcomes below will be anticipated:

- ICT Database designed for NCCR.
- Improved business/service delivery performance and efficiency through the credible database system.
- Improved skills and Management of Workflows by staff.
- Increased Operational Intelligence

Volunteer transportation within Rwanda, accommodation and meals will be taken care of by the F2F Program. Additionally, a local telephone (handset and SIM card) and internet will be provided to the volunteer at his or her arrival in Rwanda.

Rwanda has very good weather patterns. In the heart of Africa, fractionally south of the equator, Rwanda's relatively high altitude provides it with a remarkably pleasant tropical highland climate, albeit also with plenty of rain. Temperatures vary considerably between locations depending on their altitude, but very little from month to month in the same place. In the capital where the volunteer will be staying, Kigali, the temperatures vary from 20°C to 30°C degrees.

From June to mid-September is the long dry season; during dry season, there is often light cloud cover. This helps to moderate the temperatures. It's mostly hot during the day and cool at night. Appropriate dressing is recommended for the volunteer.

- **Assignment Materials:**
In case the volunteer prepares materials for hand out, can be printed at CRS office in Rwanda. Regarding Flip charts, markers, and a projector if needed, can be obtained at CRS Rwanda office.
- **Working Environment**
The assignment will be conducted at the venue provided by NCCR whose office is in Munanira II cell/Nyakabanda Sector/Nyarugenge District, Kigali City. The volunteer will work closely with NCCR management and staff, and in country F2F Field team as well.
