A. BACKGROUND

CRS Farmer-to-Farmer (F2F) Program is a USAID funded 5-year program (July 2018 – June 2023) that will provide technical assistance from United States (U.S) volunteers to farmers, farmer groups (cooperatives and associations), agribusinesses and other agriculture sector institutions. The program objectives are to facilitate economic growth within targeted agriculture sub-sectors, enhance sub-sector inclusiveness to expand participation to a broader range of individuals and communities and to increase the American public's understanding of international development issues and US international development programs. Volunteers, recruited from all States and the District of Columbia, are individuals who have domestic careers, farms and agribusinesses, or are retirees who want to participate in development efforts. F2F program will assist in agriculture development, commodity value chain competitiveness and firm

upgrading by providing technical assistance to introduce new technologies, innovations and development of local capacity for more productive, profitable, sustainable and equitable agriculture systems.

The Timor-Leste Ministry of Agriculture and Fisheries Strategic Plan¹ recognizes the fundamental importance of agriculture to Timor-Leste's economy and the impact of agriculture on poverty reduction, food and nutrition security, economic growth, and income and employment generation through its linkages to other sectors of the economy. The agriculture sector in Timor-Leste accounted for 19% of Gross Domestic Product (GDP), or over \$253 million in 2013. However, there is a considerable net deficit in agricultural trade as imports in 2014 were valued at approximately \$60 million. Major imports include rice, sugar, meat (chicken, beef, pork), vegetable oil, fish, milk, and vegetables (potato, onion)². In rural communities 57% of women and 60% of men are actively involved in agriculture³. Agriculture consists primarily of subsistence farming with limited access to inputs, technical knowledge, and market linkages. There is a heavy reliance on traditional agricultural practices such as slash-and-burn cultivation. Most smallholdings are mixed rainfed farms growing maize, cassava, red kidney beans, sweet potato, rice, groundnut, and vegetables. Coffee, coconut and candlenut are the most common tree crops. Livestock, such as poultry, pigs, cattle, buffalo, goats and sheep are raised on a small-scale and extensive.

Centro Dezenvolvimentu Communiatrio (CDC) is local Non-governmental organization that established in 2000 and localize in Triloca, Baucau Municipality. This organization was recognized as Professional training center that deliver training to unemployed youth and communities in rural area through provide horticulture activity that could generate income for the sustainability of the local product with the objectives to promote local product to generate sustainable income to both youth and community, support local product to be sell not only within Baucau municipality but as well as to other municipalities, generate advocacy to attract support from government to promote local product and to improve the capacity of entrepreneurs in rural area of Baucau as well as other municipalities.

B. ISSUE DESCRIPTION

The CDC initiated farming activities at Triloca Baucau that serve both for training center for unemployed youth on horticulture production to prepare youth with horticulture background to implement their own farm after the completion of the training, in the meantime the training also facilitated them with strong horticulture background and language skills to become qualified and certified to become seasonal workers in Australia one of the most seeking job in Timor-Leste and possibly some other countries that required horticulture skills.

There are two ways used by CDC to sell the their products, first the buyers come directly to CDC Farm and second CDC loads their products on the truck and sell to markets in Dili, Viqueque, Liquiça and Maliana Municipalities.

Currently CDC planting Tomatoes, Kangkong, Zucchini, and Papaya. The income they earned from the vegetables they are producing currently around U\$D 500 a year, and they wish to increase the production up to U\$D 1000 a year in the same size of land they have. CDC has a large land area 6 hectares and enough

people to work on the farm, but they have limited knowledge and skills on horticulture production to increase the vegetables production. The limited knowledge and skill of teachers on soil preparation, seedling, soil management & composting, pest and disease management are believed to be the cause of the low production itself.

Previously CDC has the same issues with tomatoes, the lack of knowledge to produce proper manual on tomato teaching is believed to be the main issue, to address this F2F has bring the volunteer Chelsea Johnson on July 2019 to work with CDC trainers to develop a proper manual for tomato teaching. With this manual it is expected that the technique and method could be improved in order to increase the tomatoes production. Currently tomatoes production from CDC farm in 1 Hectare land is around U\$D 3000.00-5000.00/year, and it is estimated can reach to 10.000.00/year when they implemented the knowledge and skill based on Tomato teaching manual that has been produced and also fill in some other gaps that has caused by the low production of tomatoes such as the method and techniques to improve the production.

C. OBJECTIVES OF THE ASSIGNMENT

In Timor-Leste the consumption and business of horticulture product as vegetables is quite promising. AS mentioned above, besides of being as training center CDC also has farm that produces various horticulture products to consume and sell for the sustainability of the training center.

The main objective of the assignment is aiming to improve the production of vegetables through the volunteer teaching assistance by improving the skills and knowledge on trainer and students on soil preparation, seedling, soil management & composting, pest and disease management. Anticipated training topics include but are not limited to the following;

- General organic management practices
- Crop management for dry and wet season
- Pruning for Tomato
- Pesticide register for use in Organic production

D. HOST CONTRIBUTION

The contribution of the CDC will be the simple meal for breakfast and lunch during the working hour, the transportation to pick up and drop volunteer from hotel to CDC office and also potentially to visit CDC's partners during the assignment and the translation for the volunteer during his/her time in delivering the assignment.

E. ANTICIPATED RESULTS FROM THE ASSIGNMENT

It is anticipated that this volunteer's technical assistance will contribute to improved knowledge and skills of the Teachers, Students resulting in meeting its goal of technically assisting the staffs of the CDC in Organic vegetables production. The volunteer will contribute to the following

• Teacher and Student with improved knowledge and skill on Basic Organic vegetables production, proper seedling, soil management and composting, Tomato pruning and pest and diseases management

• Better production, price and increased amount of money through selling the product
