A. BACKGROUND

CRS Farmer-to-Farmer (F2F) Program is a USAID funded 5-year program (July 2018 – June 2023) that will provide technical assistance from United States (U.S) volunteers to farmers, farmer groups (cooperatives and associations), agribusinesses and other agriculture sector institutions. The program objectives are to facilitate economic growth within targeted agriculture sub-sectors, enhance sub-sector inclusiveness to expand participation to a broader range of individuals and communities and to increase the American public's understanding of international development issues and US international development programs. Volunteers, recruited from all States and the District of Columbia, are individuals who have domestic careers, farms and

agribusinesses, or are retirees who want to participate in development efforts. F2F program will assist in agriculture development, commodity value chain competitiveness and firm upgrading by providing technical assistance to introduce new technologies, innovations and development of local capacity for more productive, profitable, sustainable and equitable agriculture systems.

The Timor-Leste Ministry of Agriculture and Fisheries Strategic Plan² recognizes the fundamental importance of agriculture to Timor-Leste's economy and the impact of agriculture on poverty reduction, food and nutrition security, economic growth, and income and employment generation through its linkages to other sectors of the economy. The agriculture sector in Timor-Leste accounted for 19% of Gross Domestic Product (GDP), or over \$253 million in 2013. However, there is a considerable net deficit in agricultural trade as imports in 2014 were valued at approximately \$60 million. Major imports include rice, sugar, meat (chicken, beef, pork), vegetable oil, fish, milk, and vegetables (potato, onion)2. In rural communities 57% of women and 60% of men are actively involved in agriculture3. Agriculture consists primarily of subsistence farming with limited access to inputs, technical knowledge, and market linkages. There is a heavy reliance on traditional agricultural practices such as slash-and-burn cultivation. Most smallholdings are mixed rainfed farms growing maize, cassava, red kidney beans, sweet potato, rice, groundnut, and vegetables. Coffee, coconut and candlenut are the most common tree crops. Livestock, such as poultry, pigs, cattle, buffalo, goats and sheep are raised on a small-scale and extensive

Nova Casa Fresca is an Agribusiness company established in 2015 with the mission of contributing to Timor Leste's economy by producing and promoting organic agricultural products. The company's objectives include:

- Produce and provide horticultural products, livestock and fisheries to local and intenational markets
- Create competition between the local and imported products which is dominating in Timor-Leste market system as a result of economical advantagees
- To attract foreigners and Timorese for high quality of local produce

The company is managed by Mrs. Hergui Luina Fernandes Alves, a female entrepreneur, and is located in Colmera, Dili, sub district of Dili. The company enjoys a working network with local restaurants and one of the largest supermarkets in the country- W Four and Falintil-Forca Devesa Timor Leste(FFDTL). The standing order FFDTL and from W- Four to supply vegetables and fruits (strawberries) is an important first step for the company to get involved in the horticulture market in Timor-Leste.

NCF understands the presence of a growing demand for horticulture products in the country as well as the need for having a strong supply chain to ensure regular supply of products to the market. To support this vision, NCF seeks to organize a strong supply chain based on working closely with farmers in Aileu in order to secure a steady and good quality supply of vegetables, closely aligned with demand from the market and they also manage their own land to produce vegetables to back up if farmer production decreases.

Since inception, the company has tried out a few ways of engaging and working with farmers to supply against market demand. This has involved distribution of some Agricultural inputs on credit, such as vegetable seeds, plastic tunnels and plastic mulch to some farmers. NCF has also tried to provide limited information on cultivation and usage of inputs. However, none of these initiatives have been successful as NCF lacks the capacity to provide technical support to improve productivity of farmers to meet the quantity and quality of products as required by NCF (which is further set by their buyers) and currently through F2F to famer program comence train NCF staff to assit farmer groups how to manage the production thru utilize qulity of compost,

liquid manure and orgaanic pest and deases control and catering services by collecting vegetables from nearly 150 farmers from their farm gate.

B. ISSUE DESCRIPTION

NCF would like to build two units Green Houses in Aileu to grow Capsicum and Beef Tomato, which is still depending on import products. are exploring different funding/investment opportunities. One potential opportunity is with CRS through impact invesment however, the requested loan was a lot larger compared to its revenue size. (more information on this will be provided separately).

C. OBJECTIVES OF THE ASSIGNMENT

The objective of this assignment is for an ag economist or financial expert to work with NCF to examine the market, analyze the technical and production issues, and analyze the economic factors faced by the host. The volunteer will focus on reviewing:

- Market Analysis (sales)
- Financial Statements
- Investment Plan

The volunteer needs to guide them through how each of these investments will bring additional revenue to NCF (understand their market and make realistic sales projections given the current economic/political situation of the country). Then he will need to construct different cash flows considering incremental revenues and costs (including the loan) per project to have a better understanding of their payment capacity in each scenario **HOST CONTRIBUTION**
