Mlegula, Production Manager, +255 – (0)655-767-187 which is a rice processing facility. Another was Highland Seed Growers, Alinanine Shimuela, Production Manager, +255-(0)754-465-806 a processor and marketer of cereal and pulse seeds. At both of these facilities the production managers told me of inefficiencies in their production capacity and expressed a desire to have engineering help to improve the capacity of their processing facilities. I told them about the Farmer-to-Farmer program and encouraged them to contact the CRS country staff and provided them with contact information. They both expressed a desire to have FtF volunteer help and training.

Portland Area Volunteer Travels to Tanzania to Share Skills with Local Farmers

Farmer to Farmer program promotes economic growth and Agricultural development in East Africa

Bob Cooperrider, a **Seed and Grain Processing Specialist** from **Canby, Oregon** travelled **to Tanzania** for **3** weeks to share his technical skills and expertise with local farmers. Bob's assignment is part of Catholic Relief Services' Farmer-to-Farmer (FTF) program that promotes economic growth, food security, and agricultural development in East Africa.

"African farm businesses and farmer cooperatives need technical assistance as they increase food availability through mechanization, As a retired farm business owner, engineer, and educator I am pleased to share my experience by training others as a volunteer in the USAID Farmer to Farmer program." said **Bob**.

Funded by the U.S. Agency for International Development (USAID), the five-year program matches the technical assistance of U.S. farmers, agribusinesses, cooperatives, and universities to help farmers in developing countries improve agricultural productivity, access new markets, and increase their incomes.

In Tanzania, Bob Cooperrider worked with Khebandza Marketing Co. in processing plant efficiency training and giving technical assistance to plant owners and operators to enable







them to improve efficiency and increase capacity of corn milling and sunflower oil processing. Up to 12 beneficiaries were reached.

Bob Cooperrider's volunteer assignment is one of nearly 500 assignments that focus on agriculture, food security and nutrition in Ethiopia, Tanzania, Kenya and Uganda. This is the first time CRS has been involved in the 28-year-old Farmer-to-Farmer Program funded by the U.S. government.

CRS is partnering with five U.S. institutions to tap into the rich diversity of the U.S. agriculture community: the National Catholic Rural Life Conference, Foods Resource Bank, National Association of Agricultural Educators, American Agri-Women, and the University of Illinois' College of Agricultural, Consumer and Environmental Sciences.

The U.S. volunteers will travel to East Africa for anywhere from one to six weeks, their expenses covered by USAID.

"One thing we are certain of is that this program will be beneficial not just to the farmers in East Africa, but also to the volunteers from America," said Bruce White, CRS' director for the program. "It's going to make the world a little bit smaller for everyone involved."
