1.2.1 Objective 1 in your SOW

- a) Enhance the capacity of staff in the management of KPTC funds through training the accounting staff on the best accounting practices
- b) Expected impacts/results:
 - a. Installation of QuickBooks 2014 Enterprise Edition
 - i. All financial entries to the books and records entered into a single source financial accounting database reducing accounting errors.
 - ii. Standardization of Chart of Accounts, Departments (Class List) and Items in the accounts of KPTC
 - b. Training Accounts Section staff on the use of QuickBooks 2014 Enterprise Edition
 - Detail training of Finance Manager, Accountant and Assistant Accountant in the operation and functionalities of QuickBooks 2014 Enterprise Edition using a practical exercise and KPTC daily financial entries.
 - c. Implementation of QuickBooks 2014 Enterprise Edition.
 - i. The combining all accounting functions, except for physical inventory count, into a business Accounting software package.
 - ii. Daily input of all accounting transactions resulting in accurate financial management of KPTC.

c) Recommendations¹

- Obtain training using the physical inventory function of QuickBooks and integrate it into the daily accounting function of KPTC
- Create an update plan to a QuickBooks Enterprise edition that is capable
 of running on Microsoft Windows 10 Platform (2014 Enterprise does not
 run on Windows 10)
- 3. Establish historical value of assets and calculate accumulated depreciation to create an accurate balance sheet of KPTC

4. Purchase Uninterruptable Power Supplies (UPS) for all computers. The inconsistent power supply at KPTC results in unexpected loss of power several times daily. Computers without UPS incur a violent shut down that results in loss data and the threat of hard drive corruption resulting in the loss of data critical to the operation of KPTC.

[City] Area Volunteer Travels to Uganda to Share Skills with Local Farmers

Farmer to Farmer program promotes economic growth and Agricultural development in East Africa

Michael Mayott, a **volunteer** from **Billings**, **MT** travelled **to Tanzania** for **3** weeks to share his technical skills and expertise with local farmers. Mike's assignment is part of Catholic Relief Services' Farmer-to-Farmer (FTF) program that promotes economic growth, food security, and agricultural development in East Africa.

Funded by the U.S. Agency for International Development (USAID), the five-year program matches the technical assistance of U.S. farmers, agribusinesses, cooperatives, and universities to







help farmers in developing countries improve agricultural productivity, access new markets, and increase their incomes.

In **Tanzinia**, **Mike** worked with **Kilacha Production & training Center** implementation and training on QuickBooks 2014 Enterprise Edition and giving technical assistance to **their staff** and **Board of Directors** to enable them to **automate their accounting records**.

Mike's volunteer assignment is one of nearly 500 assignments that focus on agriculture, food security and nutrition in Ethiopia, Tanzania, Kenya and Uganda. This is the first time CRS has been involved in the 28-year-old Farmer-to-Farmer Program funded by the U.S. government.

CRS is partnering with five U.S. institutions to tap into the rich diversity of the U.S. agriculture community: the National Catholic Rural Life Conference, Foods Resource Bank, National Association of Agricultural Educators, American Agri-Women, and the University of Illinois' College of Agricultural, Consumer and Environmental Sciences.

The U.S. volunteers will travel to East Africa for anywhere from one to six weeks, their expenses covered by USAID.

"One thing we are certain of is that this program will be beneficial not just to the farmers in East Africa, but also to the volunteers from America," said Bruce White, CRS' director for the program. "It's going to make the world a little bit smaller for everyone involved."
