- 1.2.1 Develop a 5-year strategic plan that provides a framework within which OATC can operate
 - a) Progress with the objective: 85% complete
 - b) Expected impacts/results:
 - Focus with prioritization for especially the next year so infrastructure can be improved. This will help OATC be able to position itself to better manage its sustainability generating managed income from within multiple agric enterprises and be able to appeal to more external funding (i.e. loans for microcredit, domestic violence training.)
 - c) Recommendations:
 - Establish financial management and accounting system. Include microcredit software and correction on interest calculation.
 - Uganda Natl Standard Board Registration for sunflower oil and milled rice to be able to sell into better markets/ larger quantity, bulk purchases.
 - Quality control training applicable to milled rice and sunflower oil operation as well as the animal and agriculture operations.
 - Internet and file sharing solutions.
 - Master list of supporters from past and add new ones: promote to them (Facebook, emails, etc. with activity like crowdfunding to grow microcredit loan fund)

1.5 Gender

a) What gender roles did you recognize in your host community? Did these roles play a part in your assignment? How?

Women spoke up more when Director (male) was gone. This may have been due to role of authority or male, or both.

Women doing accounting did not have all information and records for things the Director (male) did like the bank cash, other cash, negotiated invoices, financial arrangement with prison labor, etc. This may have been due to Director's role, or other reason like using the staff for other things and he could do some of the negotiation. However, the accounting role should have exposure to financial condition and been able to answer more questions than they could. The women knew about microcredit and village savings, but not enough about farm negotiations.

The organization must establish a full picture of its overall financial condition with software and this will require full transparency shared with the women handling the accounting. Demonstrated to women what the monthly and quarterly financial reports should look like. Advised to start ledgers/registers of all accounts that are currently not maintained (i.e. cash, bank cash, etc. and begin reconciling to bank's cash total.)

b) How might CRS or the host organization improve opportunities for the women in this host or host community?

Include the women of OATC in meetings about their financial management.

Encourage the director to develop the women working with accounting and financial management about decision making, why decisions are made as they are and the financial arrangements.

1.9 Recommendations for CRS:

- High priority focus to help OATC with improving financial management (Accounting software, project to transition current to software, train staff, follow-up with their use.)
- Utilize CRS IT knowledge to help assess what OATC can do for gaining better internet access and network file sharing, under the conditions of unreliable internet network and limited solar power for power at OATC during rainy season of cloudy days. Trusted advice from seasoned professional so solution is realistic.
- High priority for OATC to gain UNSB registration for milled rice and sunflower oil product. Any
 assistance of sharing standards, hygienic food processing training, quality control training, etc.
 will be helpful.
- Numerous volunteer assignments can help OATC.
 - Accounting set up, transition, and training support; draft and update to current financial management policy
 - Microcredit software support
 - Internet technology, server, upgrade of unsupported computer software (computer running on XP that Microsoft no longer supports)
 - o Training for farmers in soy milk preparation, other nutrition that can be done in area
 - Irrigation training
 - o Poultry, goats, cows hygienic maintenance
 - Food processing training
 - Quality control
 - o Training on sewing machine maintenance and repair

Seattle Area Volunteer Travels to Uganda to Share Skills with Local Farmers

Farmer to Farmer program promotes economic growth and Agricultural development in East Africa

Diana Lilla an Organizational Management Consultant from Seattle, Washington travelled to Uganda for 3 weeks to share her technical skills and expertise with local farmers. Lilla's assignment is part of Catholic Relief Services' Farmer-to-Farmer (FTF) program that promotes economic growth, food security, and agricultural development in East Africa.







"It is great to see leadership take initiative and develop agriculture farming enterprises to fund other needed programs as well as model good farming for the local farmers. I'm impressed with what they've already done in addressing poverty in farming by including a more holistic approach that includes stable families. I'm grateful to have seen their operation and being able to support them at this time." said Diana.

Funded by the U.S. Agency for International Development (USAID), the five-year program matches the technical assistance of U.S. farmers, agribusinesses, cooperatives, and universities to help farmers in developing countries improve agricultural productivity, access new markets, and increase their incomes.

In Uganda, Lilla worked with Odokibo Agriculture Training Centre in strategic planning to the farm training center to enable them to focus their efforts in next few years. Up to 113 beneficiaries were reached in Yumbe District of West Nile Region in Uganda.

Lilla's volunteer assignment is one of nearly 500 assignments that focus on agriculture, food security and nutrition in Ethiopia, Tanzania, Kenya and Uganda. This is the first time CRS has been involved in the 28-year-old Farmer-to-Farmer Program funded by the U.S. government.

CRS is partnering with five U.S. institutions to tap into the rich diversity of the U.S. agriculture community: the National Catholic Rural Life Conference, Foods Resource Bank, National Association of Agricultural Educators, American Agri-Women, and the University of Illinois' College of Agricultural, Consumer and Environmental Sciences.

The U.S. volunteers will travel to East Africa for anywhere from one to six weeks, their expenses covered by USAID.

"One thing we are certain of is that this program will be beneficial not just to the farmers in East Africa, but also to the volunteers from America," said Bruce White, CRS' director for the program. "It's going to make the world a little bit smaller for everyone involved."
