- Housing Recovery and Reconstruction Platform (HRRP) Phase 3 (Mar 2017-Feb 2019 to be extended to Jul 2019)
 - The shelter emergency cluster and HRRP Phase 2 was led by IOM.
 - The first NGO-led shelter coordination platform between donors, Government of Nepal and Partner organizations.
 - A team of 70 provides on-the-ground technical, general and information management support to the 14 most-affected districts, looking to expand reach to 32 affected districts

COUNTRY INFORMATION

Nepal is a landlocked country bordering India and China, of approximately 57,000 sq. miles and with a population of 26,500,000 people.

<u>Capital</u>: Kathmandu – population approximately 1 million in Metro Kathmandu

<u>Government</u>: Parliamentary Republic. Declared a Kingdom in 1768; Republic declared in 2008.

- <u>Currency:</u> The Rupee, which is currently valued at approximately NPR 100 to US \$1. Should you wish to change money, you will find currency exchange counters located inside the international airport within and after the customs area before you exit the airport.
- Language: There are 14 regional languages recognized in Nepal.
- <u>Religion</u>: 80 per cent Hindu, 9 per cent Buddhist, and there are small Muslim, Christian, and Animist communities.
- <u>Electricity</u>: 220-240volts AC. Some plugs work with British adapters. If you bring 110-120volt appliances, you will also need to bring a step-down converter. There is government-sanctioned load-shedding resulting in several hours a day of power outages (longer outages during the winter). Bring rechargeable batteries.
- <u>Time Zone:</u> Nepal Standard Time (UTC+5:45 does not observe Daylight Savings Time).
- <u>Climate</u>: The day weather in Nepal is warm (25 C/ 75 F) and evenings and early mornings is cold (13C/ 55F). Light woolens are recommended. Occasion rain and thundershowers are there almost every day, so a raincoat or umbrella will be handy
- <u>Banking:</u> ATMs withdrawal limit is 10,000 NPR 50,000 NPR at a time and the limitation depends on the different banks.
- <u>Credit Cards</u>: Accepted at major outlets, but not always at smaller shops

Business/Banking Hrs: 10:00 to 15:00 Sunday to Thursday; 10:00 to 13:00 Friday (Saturday closed)

<u>**Climate:**</u> Nepal is a landlocked country sharing borders with <u>**Tibet**</u> to the north and <u>**India**</u> to the west, south and east. Spring and autumn are the most pleasant seasons; winter temperatures drop to freezing, with a high level of snowfall in the mountains, while high summer can be blisteringly hot. Monsoon season begins around the end of June and lasts until the middle of September.

<u>Clothing</u>: Lightweight clothing with umbrella and layers for evenings and high mountain areas are advised for May-June 2018. Avoid wearing shorts, tight fitting clothing, sleeveless, short skirts, etc.

Food: Most of the Nepalese food comes in varying degrees of spiciness. The traditional Nepali Thali includes rice, lentils, cauliflower and pickle. There is very little beef available and consumed, but chicken and buffalo are widely available. Vegetarians have lots of options.

<u>Getting Around: In Kathmandu:</u> CRS uses CRS and rented vehicles as well as Taxis are available. Drivers are likely to have limited English, so please have the phone number of the destination available and the CRS Team is always a phone call away to assist. Always wear your seatbelt.

OCRS

For travel around the country, build in extra time for incidental delays, which may include mud slides, traffic jams and flooding. In the monsoon season (Jun-Aug), landslides can make some roads impassable.

<u>Getting Around: In Gorkha:</u> Please call the CRS driver to arrange a vehicle or you can walk freely during daylight hours. The Staff Guest House is within walking distance from the CRS Gorkha office.

NOTE: Yellow Fever Vaccination: There is no risk of yellow fever in Nepal. The government requires travelers arriving from *countries where yellow fever is present* to present proof of yellow fever vaccination. If you will be traveling from one of the countries where yellow fever is present before arriving in Nepal—even if only passing through an airport—you must take this requirement into consideration.

Cultural and contextual awareness

- Appreciate and recognize the significant amount of experience and capacity of the local staff.
- Seek input from local staff and partners.
- Recognize the efforts of the government and remember to involve them in project design and implementation.
- Take down-time with the staff for non-work relaxation, even if just a couple of minutes at the end of the day.
- When paying for something, always use your RIGHT HAND, as the left hand is considered unclean.
- Maintain awareness of your surroundings and your belongings; never leave your bag unattended. Consider carrying just the essentials with you into the field.
- People do not wear shoes inside so wear shoes that are easy to take on and off (sandals and a pair of closed shoes if you are going into the field).
- CRS staff should avoid discussions of the political, religious and/or military situation in the country when in public places, on the phone, or in the presence of strangers.



IMMIGRATION

<u>Visas</u>

- All travelers can get a visa on arrival at the Kathmandu airport. It will be a 15-day Tourist visa and will cost \$25. Note you do not need to bring a passport size photo, and you do not need to fill out a visa application form beforehand.
- After deboarding the plane, you will take a shuttle bus a short distance to the terminal. You walk about 200 meters to reach the arrivals lounge. On the left is a table with the immigration arrival forms. You will need to fill out one of the forms.
- After that table there are a row of machines that are used for the visa application. The process has been computerized and the form is done on the computer instead of on a paper form. There are airport attendants to help with the process if needed. You start by scanning your passport photo page on the machine. Then follow the prompts on the screen. It will ask for your address in Nepal. Please use Hotel Summit, Kupondole Height, Lalitpur, Kathmandu, Nepal. Phone: (977-1) 5522843. It is best to put Tourism down as the purpose of your visit. The machine will take your photo so you do not need to bring a separate passport size photo.
- When the application is complete, the machine will print out a slip. Take the slip and your passport and go to the desk at the end of the row of machines where payment is made. There you will pay \$25 (cash is simplest). They will give you two copies of the receipt. Take the receipts and proceed to the immigration line.
- Wait in a line that is marked 15/30 day visa. Give the immigration officer the arrival form that you filled out at the beginning, the receipts provided at the last desk, and your passport. They will put a visa in your passport and stamp it. Then you can proceed to baggage claim to pick up your suitcase.

- Extra passport copies and photos: please bring at least two extra photocopies of your passport pages and at least two passport photos. You will need these to purchase a SIM at the airport.

RELIGION IN NEPAL

Nepal is multi-cultural, multi-ethnic, multi-lingual and religious diverse nation with all the religions being practiced since ancient times here. Nepal is a secular state with 81.5% of the total population of Nepal being Hindu; there are an estimated 8,000 Catholics in Nepal. Strict national laws have been recently passed in October 2017 against person/organization found in conversion activities. There have been increasing religious tensions and during the month of April and May 2018, 6 churches have been burned, including one Catholic church.



CURRENT POLITICAL SITUATION

After abolishing the Monarchy, Nepal was declared Federal Democratic Republic of Nepal in 2008. In October of 2017, Nepal had its first local-level election after decades followed by the House of Representative election in November/December 2017. Nepal is currently transitioning to a Federalist decentralized structure. The newly elected Federal Parliamentary Government is led by the Communist Party-Unified Marxist/Leninist and Communist Party-Maoist Centre with Mr. Khadga Prasad Oli is currently the 38th Prime Minister of Nepal.

SAFETY & SECURITY

Security Precautions:

Nepal is considered to be a very safe country. There be an in-country orientation upon arrival to provide a thorough overview of precautions to be taken. There is no curfew in effect. Travelers should be careful of pickpockets in crowded market areas and transportation hubs. Packages, mobile phones and luggage should never be left unattended, especially in vehicles/taxis. Travelers should also be cautious of individuals who persistently offer unsolicited help. Avoid any public demonstrations as they can quickly escalate. Women enjoy the same rights and privileges as men do.
